**TAX IMPACT**



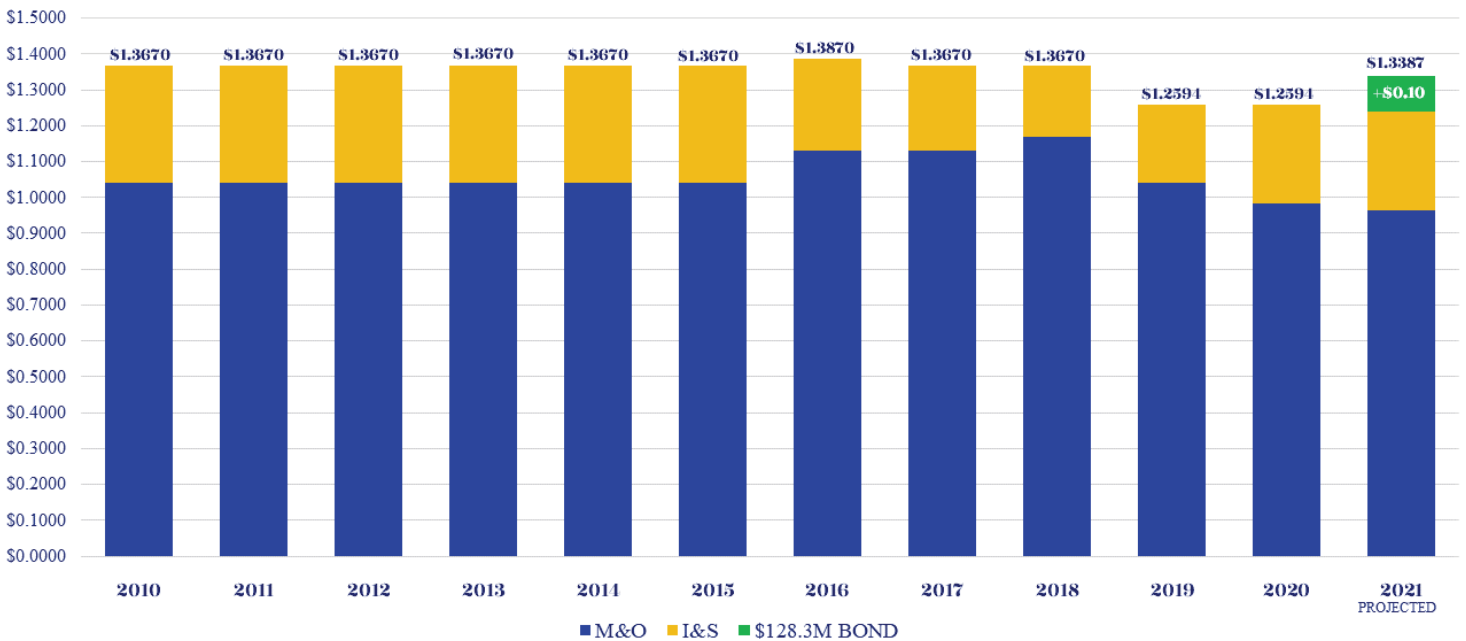
- The maximum tax rate impact of this bond election is projected to be no more than 10 cents per \$100 valuation
- **Property taxes for citizens 65 years or older will not increase above exemption ceiling on homestead property**

**\$29.11 per month**  
 for the owner of a \$349,373 home (includes homestead exemption)

 M&O Tax Rate = \$0.9835  
 I&S Tax Rate = \$0.2759  
**Total Tax Rate of Taxable Valuations = \$1.2594 per \$100**

 M&O Tax Rate = \$0.9628  
 I&S Tax Rate = \$0.3759

**SCHOOL BONDS 101**

School bonds are very similar to a mortgage on a home. To finance construction projects, the district sells bonds to investors who will be paid principal and interest. Texas law states that no bond can end more than 40 years from the date of sale. It is likely that all of the bonds will not be sold in one sale, and therefore the tax rate will increase over time to the maximum estimated I&S rate of \$0.3759, once all the bonds have been issued.
